APA Referencing Basics: In-Text Citation In-text references must be included following the use of a quote or paraphrase taken from another piece of work. In-text citations are citations within the main body of the text and refer to a direct quote or paraphrase. They correspond to a reference in the main reference list.

An APA in-text citation is included in research projects in three instances: When using a direct quote, paraphrasing information, or simply referring to a piece of information from another source. Quite often, researchers and scholars use a small amount of text, word for word, from another source and include it in their own research projects.

To create a reference for a chapter in an edited book, follow the example for a chapter in an edited book without a DOI. At the end of the reference, after the publisher, add the DOI using the current DOI URL format. The current standard for the DOI begins with "https://doi.org/". Do not add a period after the DOI.

Authored books that contain chapters written by other contributors are relatively uncommon, and APA Style users are so accustomed to the format for citing a chapter in an edited book that this slight change might lead your readers to assume that you are incorrectly citing an edited book by accidentally leaving out the Eds. component.
